Book of 2 Kings Chapter 17

Morning Brothers and Sisters, in the wake of the newly elected COM at the recent AGM the Lord takes us to the Book of 2 Kings. Note to self, there is no record of which prophet wrote 1 and 2 Kings. However, it documents the history of a divided kingdom in 853 BC when the nation of Assyria took captive the people of Israel. Judah was the only nation to have remained intact. Then the Babylonians took down the Assyrians Capital of Nineveh in 612 BC and by 586 BC Babylon dominated Judah. By the end of Kings, the people of God no longer inhabited their "Promised Land" and the place was destroyed by the Babylonian Army. PSU'S RELATIONSHIP WITH GOVERNMENT

The body in central government with which the Public Service Union of Belize (PSU) has the closest relation is the Ministry of the Public Service (MPS). Functioning under the leadership of the Minister for the Public Service and the management of a Chief Executive Officer (CEO), this Ministry has responsibility for the formulation and execution of the following policies of Government:

- ⇒ The recruitment and selection process of public servants
- ⇒ Human resources management and development
- ⇒ The classification of positions
- ⇒ Fixing of salary scales and privileges
- ⇒ General terms and conditions of employment
- ⇒ Transfer, promotion and disciplinary measures
- ⇒ Matters relating to the general management and control of the public service.

Taking into consideration that the MPS serves as Secretariat to the Public Services Commission (PSC), the Joint Staff Relations Council, the Administration and Accounts Posts Panel, the Human Resource Development Committee and the Council of Good Governance, the PSU's close involvement with the MPS can readily be appreciated. This is especially so when we consider their respective functions in relation to the main objectives of the PSU, which are:

- ⇒ to ensure the complete organization in the Union of all persons employed by the Government of Belize or any of its Statutory bodies;
- ⇒ to promote and protect the interest and welfare of its members including obtaining and maintaining proper rates of salaries and other conditions of employment;
- ⇒ to uplift the status of the public service;
- ⇒ to regulate an effective bargaining body to negotiate on behalf of its members;
- ⇒ to regulate by amicable means the relations between Government/Management;
- ⇒ to promote mutual respect and goodwill, loyalty and cooperation in the best interest of the public servants and the public;
- ⇒ to provide Trade Union benefits for members;
- ⇒ to promote the general improvement of the public service;
- ⇒ to promote legislation in the interest of its members.

Although the MPS appears to want to enhance good relations between the MPS and the PSU by taking steps aimed to 'modernize' the Public Service by embarking on initiatives to provide for long-term reform measures, the reality is that most of these have since been corrupted and used against public officers. - ⇒ In its goal to have improved service delivery by means of highly motivated productive employees the Ministry, in partnership with the PSU, the Public Services Commission and the Public Sector Reform Council, formulated an **Employee Assistance Programme (EAP)** policy framework.
- ⇒ *Sadly, certain heads of departments twisted the EAP and now use it as a punitive measure in their personal attacks on certain officers.
- ⇒ In 1997, a new output oriented **Performance Appraisal System** was introduced.
- ⇒ *This too has failed to meet the intended purpose as supervisors continue to give unjustified assessment reports on their subordinates without any oversight/intervention from the MPS.
- ⇒ The **Public Service Regulations** governing public servants was updated in 2014.
- ⇒ *This is still a matter of concern because it has been enforced without being previously accepted by the PSU.
- ⇒ To have greater efficiency in the day-to-day management of personnel issues **Operations Manuals**, in respect of appointments, promotions, transfers, recruitment and discipline, were produced.
- ⇒ *The MPS is itself not adhering to these Operation Manuals and only do so when it is convenient to them.
- ⇒ To automate its personnel management system completely, the Ministry instituted a **Human Resource Management Information System (HRMIS)**, and produced a Staff List in 2014 as the first product of the new system.
- ⇒ *This is still a challenge for the Audit Department as CITO blocked most of the staff from accessing information that was previously available for them to conduct payroll related audits.

It is therefore critical that MPS revisits these "initiatives" along with the PSU to ensure the intended purpose, that they benefit our public officers, is realized. It also brings to light the fact that the PSU needs to consistently monitor and bring to the attention of the MPS when these joint initiatives are used for sinister purposes against our public officers. The involvement of PSU must be from planning, through implementation and beyond, to ensure that all stakeholders respect fair play for the intended benefit of all public officers.



GOVERNOR'S "EMERGENCY" DENIES DISSENT. P.S.U. STRIKE CONTINUES STRONG.

BELIZE'S GOVERNOR JAMES HENNESSEY gave in to pressures from the Premier of Belize, Mr. George Price on Thursday by signing a proclamation declaring a state of emergency. The proclamation was signed shortly after 2:30 p.m. on Thursday, just two hours after giving an assurance to the Public Service Union that he would not try to prejudice their strike in this way.

Governor Hennessey decided to act after receiving reports of violence in Corozal Town, in which one well known member of the opposition was shot and killed, and the prospect of

Yesterday's proclamation was made under Section 62 of the British Honduras Constitution Ordinance No. 33 of 1963 which gives the Governor power to suspend any law he choses to suspend and to substitute for these written regulations which appear to him to be necessary and expedient for the securing of public safety, maintenance of order public order, suppression of mutiny, rebellion and riot and maintenance of supplies and services essential to the life of the community.

Under this last named maintenance of essential services the Electricity

to refrain from assemblying in groups of more than five and to co-operate with the authorities if these decide to requisition any private property for the purpose of maintaining good public

Since Thursday two new regulations have been added. One prohibits the use of picket signs and the other prohibits the use of loudspeakers as a way of communicating with people. So far no regulations have been made prohibiting the printing or circulation of newspapers, but it might come to that before the emergency is over.

or some time, the Public Service Union has been trying to acquire its own office building in Belmopan.

To this end, members of the Executive of the Union have been in fialogue with various agencies and individuals culminating with a neeting with the Ho. Prime Minister and other Government Officials on the 26th January 2001. The end result of that meeting was that he Prime Minister agreed to the leasing of the Hilltop Complex to the Union for a period of 20 (twenty) years.

Following up on this agreement, a letter dated 8th February 2001, was issued to the Chairman of Reconstruction and Development Corporation, Hon. Agripino Cawich,

by the office of the Cabinet Secretary. In that letter reference was made to the fact that as far back as May 1999, Cabinet had decided hat "The Hilltop property and facilities should be taken over and nanaged by the Public Service Union and that a formal leasing of he property be effected". The letter further went on to exhort the Chairman to support the agreement reached and conclude an urrangement to enable the Public Service union to be issued with he lease without further delay. This correspondence was copied of the Mayor of Belmopan requesting his support in lending his good office to the effort to facilitate the early conclusion of the matter.

Consequent to this development, the President of the Union met with the Mayor in February 2001 the result being the issuance of a Draft Lease agreement, which is now being actively pursued by the Union. This Draft agreement is being vetted by the Union's Attorney. In the meantime, the Union has prepared a ten (10) year development plan for submission to the Council to facilitate the inalization of the lease agreement.

The plan indicates that the development of the Hilltop complex will be undertaken in two phases as follows:

Dear Editor

Most of us use the Belize Bus System or National Public Transportation System. I am ONLY looking and referring to the system of moving Belizeans in this country from Corozal to Toledo and from Benque Viejo to Belize City.

The first issue is that the buses that are being used in Belize are used for moving children in the United States and not designed for moving adults. Also, some of the buses are too old to be on the road and it takes too long to get new and modern, fuel efficient and safer buses for all of us to use. The Government of Belize needs to fix this problem, but then again this might be asking too much. The routes for the entire transport system needs to be improved by making the process more transparent and the National Transport Board needs to come clean on how this system works for the country, given that the system is not working for us who use the Public Transport System here in Belize.

The Minister responsible for National Transport System needs to give up his Government issued vehicle that is provided for by the people of Belize and ride the Public Transport System for one (1) month. If he does use the Public Transport system for less than a month, he will not truly understand the issues that commuters face on a daily basis given the nature of the system and the inefficiencies that governs the entire system. He should also use the transport system to get from home to work; furthermore he also needs to be on time for all his meetings.

Being on time does not have any meaning in Belize given the way the terminals are being managed. Something needs to be done to fix the entire system given all these problems.

Ticketing should be mandatory for all Bus Companies and they need to put one that works in place.

I do not want to make the Prime Minister ride the transport system because of his back problem because it will certainly affect his health. If only he can get a feel as to what we all go through for using the Public Transport System. Cabinet does not have a problem with this system because it does not affect them. I may also need to request the participation of all other members of Cabinet for them to use and experience this system to get around, meet their obligations and to be there on time. I would like to ask the Chairman of the National Transport Board if the system is working most efficiently and what are some of the fixes that are needed to vastly improve the current system.

I do remember listening to a radio show once where Mr. C. Jefferies and Mr. P. Schmidt from the Transport Department where disagreeing on the ways the system can be fixed. We all need to help in finding solutions to this problem.

It was suggested recently that the buses be improved over time about 10 Years. This is too long, and the Government of Belize needs to help in fixing this problem earlier given the importance to our society.

I also empathize with commuters that live in between the major urban towns where the buses commence their day. If you live in between and in these areas of the route; I pray for you daily for traveling mercies and for you having to rely on the bus system to get you to work on time. How many times have you been left on the side of the road waiting for a bus? The buses coming full will leave you on the road because standees are no longer tolerated. Something needs to give on this issue and we all need to find ways of fixing this problem.

The National Transport Master Plan is available for all of us to review. The only problem is the size of the document but then again, if we want to fix this problem we have work to do.

We all need to find solutions to this problem now. Solidarity forever.

KHMH, BRINTS SECURITY, AND THE MINISTER OF STATE IN THE MINISTRY OF HEALTH

On May 21st 2019 the Press Office issued a press release informing that the Office of the Prime Minister had directed that Minister of State in the Ministry of Health, Hon. Dr. Angel Campos be reassigned as Minister of State in the Ministry of Human Development, Social Transformation and Poverty Alleviation effective 21st May 2019. While no explanation was given in the press release for the sudden reassignment of Hon. Dr. Angel Campos, Public Officers and the General Public are left to wonder if it had anything to do with recent scathing allegations made by the principal of Brints Security who published the following on Brints Security facebook page: "However Brints Security made very clear for a third time that the minister of state in Health (transferred) and a director from KHMH did bribed the company several times and welcomes them to court to prove they are corrupt."

While the International Anti-Corruption Day will not be celebrated until December 9th, the Public Service Union of Belize sees it fitting to remind Public Officers daily that corruption affects us all. It threatens sustainable economic development, ethical values and justice; it destabilizes our society and endangers the rule of law. It undermines the institutions and values of our democracy. But because public policies and public resources are largely beneficial to poor people, it is they who suffer the harmful effects of corruption most grievously. The Government of Belize (GOB) signed onto to the United Nation's Convention Against Corruption (UNCAC) on Friday, December 9th, making Belize the 184th country to sign this convention.

SANTUARY BELIZE, US FEDERAL TRADE COMMISSION, THE SENATOR AND ATLANTIC INTERNATIONAL BANK

On November 8, 2018 the United States Federal Trade Commission (FTC) announced that it had uncovered the largest international real estate fraud in its history. "Sanctuary Belize", the FTC says, is a \$100 -million scheme that the commission has filed court papers in Maryland District Court to shut down. Sanctuary Belize has swindled US investors out of millions of dollars, the FTC has alleged. On May 20, 2019 while addressing the media the Hon Prime Minister stated: "I had indicated to the FTC, we want to settle the matter. It's not for the government or the Central Bank, because if the Central Bank tries to get involved in a commercial settlement, it would lose its immunity from suits and from attachment." Inter alia...." because we have an interest in seeing a settlement we will do whatever we can to encourage the liquidator". It is extremely important that Public Officers pay attention to this issue. In addition to already landing the Government Senator and Attorney for Atlantic International Bank Limited Aldo Salazar in hot water, the real estate fraud has already caused the Atlantic International Bank Limited to wound up operations in Belize because of the allegations levied against it by the US Federal Agency. With the FTC determined to ensure that its US investors in the scheme recover their money, Public Officers must remain vigilant to ensure that not a penny from taxpayer's dollars' in the consolidated fund is used to settle this private debt between the FTC and Sanctuary Belize. Let's not forget the Universal Health Services loan fiasco, for those who cannot learn from history are doomed to repeat it.

The Social Contract

The Social Contract helped inspire political reforms or revolutions in Europe, especially in France. We refer to all of these countries as First World countries because of the level of their social development. If the Social Contract was so influential to their positive development, then Belize should consider adopting its principles for the benefit of its citizens. A powerful Public Service Union can play a major role in ensuring that the Government adheres to the contract.

Firstly, we must understand what the Social Contract is. Socrates is credited with coming up with the concept from as far back as the years before Christ. Jean-Jacques Rousseau made the theory modern in a book he wrote back in 1762. Not to bore anyone with too much history, we will discuss the basic principles of the theory.

The theory essentially states that there should be two divisions in a society: the majority of the society (called the sovereign because they should be "free") and a few chosen as leaders (the government). The theory however rejects the idea of a government in which only those few individuals benefit from the work of the majority (the sovereign) in any society. It also states that the rulers of the country do not get their power from God, but from the majority of the society who elected them to be the leaders. Therefore, it is the majority of society that has the POWERFUL exclusive right to remove leaders from power whenever they decide change is needed. However, only if such a society is "free" can they truly exercise their right to remove their leaders at any time.

The word "free" is not meant in the physical sense of someone being able to move around, as he/she wants. It refers to all forms of freedom including the freedom to think, express an opinion and make decisions without the fear of victimization or threat of any kind. Sadly, today too many persons in society choose to become mental slaves because they allow themselves to get dependent on those in power (the government).

The sovereign (free society) forms when free and equal persons come together and agree to make themselves as a single body. Therefore, just as individual wills focus towards individual interests, the general will, once formed, concentrates on the unified common good, which is understood and agreed to collectively. Included in this version of the social contract is the idea of shared duties: the sovereign is committed to the good of the individuals who form it, and each individual is likewise committed to the good of the whole. Given this, individuals cannot be given freedom to decide whether it is in their own interests to fulfil their duties to the sovereign, while at the same time being allowed to reap the benefits of citizenship. They must obey the general will; they must be "forced to be free". The general will depends on the entire democratic body coming together every so often; each citizen decides collectively, and with at least near unity, how to live together, i.e., what laws, rules and regulations to enact.

The basic problem that the contract theory tries to address is how can we be free and at the same time live together? *Cont on pg 14*

In other words, how can we live together without giving in to the power and pressures from others? According to Rousseau, we do so by letting go of our selfish wants and desires to join a group that wants everyone to benefit equally. This can only occur if we come to an agreement with other free and equal persons. Nature made all men to be equals, therefore no one has a natural right to govern others, and therefore the only justified authority is the authority generated out of agreements or contracts.

Rousseau's social contract theories together form a single, consistent view of our moral and political situation. We are blessed with freedom and equality by nature, but our human nature has been corrupted by our dependent social history on politicians to provide for us. We can overcome this corruption, however, by invoking our free will to reorganise ourselves politically, along strongly democratic principles, which is good for us, both individually and collectively.

PSR 2014 Review

The Belmopan Branch took up the initiative to host two (2) Workshops to review the Public Service Regulations (PSR) 2014 on 22nd & 29th of May 2019. These workshops were set as an Open Discussion Session to review changes made between 2001 & 2014, benefits gained and lost and the way forward. The end result of the Workshops is to present amendments to the PSR 2014 along with a way forward in creating a new Public Service Regulations 2020. At the end of the first day of the two day workshop, it was noted that the Workshop will need at least 2 or 3 more sessions along with 2 more Administrative Officers who know the system and the regulations. These will be held sometime in late June or early July after the new Council of Management has settled in and a report has been given. Some of the takeaways from the Workshop include: a number of sections in the PSR were too ambiguous, Public Servants lost numerous benefits, the Regulations are not being upheld by many CEOs, HoDs & AOs, and the updated regulations opened Pandora's Box in regards to hiring retired officers as Contract Officers.
